### **LEGAL FLYER FOR THE PROTEST MARCH (Germany and France)**

Some tips for demonstrations and during arrest in Germany and France. (For Luxembourg and Belgium you will get more info in June)

# General:

- <u>Affinity Group:</u> Do not be alone in a protest. With your group of 3-5 people you are safer.
- What do you need: The legal telephone number (on your arm), telephone, pen and paper.
- What should you not bring with you: Alcohol, drugs, knives, weapons, address books
- <u>During police repression:</u> stay together! stay calm and be aware, make chains.
- Reported due to insults: Be careful what you say about the police, they often react by filing a report.
- <u>Disguise is prosecutable</u>: do not hide your face
- Write down what the police do
  - Name and address of those affected
  - Place, time and type (arrest, beating) of the attack.
  - Witnesses (names, contacts, and how many)
  - Service type and description of the police officer, number on their helmet/ the uniform.

This witness statement is necessary for the legal team, keep it secure.

#### During arrest:

- Make yourself noticeable! Shout!
- Call out your name, address and date of birth, so that other people can inform the legal team.
- Do not say anything to the police! (except your personal details)
- Demand your rights: Translation, lawyer, medical examination if you have been injured, the reason for arrest.
- Do not tolerate any violence, neither physical nor verbal.

### Germany

- Residenzpflicht (duty of residence):
- If you are in an asylum process in Germany or you have a Duldung (toleration) then you can be accused of breaking the **Residenzpflicht.** Mostly that means a fine.

Stay calm and inform the Legal-Team: 0049 1575-0676804.

- During arrest (Festnahmen):
- You should declare the following (at the police station):
  - Name, date of birth, family status, occupation and address. Place of birth and country alongside citizenship should also be declared, unless you have been illegalised and under threat of deportation.
- Do not say anything more (to questions, the situation...)
- **Do not sign anything!** (also when they put you under pressure, you have the right not to say anything and not to sign anything!)
- You have the right to make **two telephone calls**! Insist on it.
- Ring the legal team! 0049 1575-0676804
- Demand translation
- Demand as required medical examination.
- Demand, if needed, a lawyer
- If you do not have status in Germany (illegalized) you should **make a (second) bid for asylum with the support of a lawyer.**

### Indentity check (Identitätsfeststellung)

In order to check over your details, you can be held for a maximum of 12 hours.

<u>Police custody (Polizeigewahrsam):</u> maximum of 48 hours, except if you are going to be presented before a magistrate and a pretrial detention has been ordered.

#### **France**

#### Identity Check (Le contrôle d'indentité):

- Do not declare anything except for your name, second name, date and place of birth. You do not have to answer any other questions.
- The police have the right to perform a superficial search. They cannot perform a full body search
- If the police are not "satisfied" with your papers, they can bring you to the station to verify your identity.

### Verifying identity (La Vérification d'intité):

- This may not last for longer than four hours from the start of the inspection.
- You may inform a person whom you trust. (Legal-Team: 0049 1575-0676804.)
- Only give details about your own person. You to not have to answer any other questions.
- If you give a false identity or refuse to give your identity, the police can take fingerprints and photos
- After four hours you must either be released or taken into custody.

#### Police Custody (garde à vue):

- After you have given your personal details (<u>First and last name</u>, <u>place and date of birth</u>) you have the <u>right to</u> be silent.
- In custody in France you cannot contact the Legal-Team yourself when required.
- Demand translation
- · Demand medical examination as needed
- Demand a lawyer
- You have to request a court appointed lawyer (**l'advocat connis d'office**) which will then be called by the police.
- If you are presented before a judge, ask your court appointed lawyer if they are a member of the 'Legal Team'. If not, tell them that you want to be assigned a lawyer who is part of the 'Legal Team'.
- Police custody can last up to 24 hours and can be renewed once.
- Inform the Legal Team of your release as quickly as possible and write a witness statement.

## Additionally for those without a European Passport:

You have the right to contact the embassy/embassador and a person of your choice. Please ask this person to let the **Legal Team** know or ring yourself on: 0049 1575-0676804.

Demand as quickly as possible to talk to a person from CIMADE (a French NGO, which specializes in taking care of people without papers in France).

In some situations it makes sense to make a (second) bid for asylum with the support of a lawyer! (Je demande d'asile)
